2025 Call for Photographers: Noir et Blanc

Black and white and monochrome photography often evoke much emotion, nostalgia, and narrative. The absence of color helps the viewer see the subject, the contrasts, and the important elements of the image without distractions. This call for monochromatic and black and white photography includes both analog or digital formats of image capture and output. A variety of subjects will be considered and include but are not limited to: landscape, portraiture, still life, photojournalism, architectural, abstract or alternative processes.



High School students are invited to submit artwork for consideration for this exhibit.

CRITERIA All photographic genre are welcome: portraits, landscapes, photojournalism, and macro photography. Composite photography is accepted as long as the elements in the final image are the work of the photographer. All work must be original. Submitted work must be the artist's own. The use of Generative Al is not permitted. Images using Generative Al will not be accepted. Works previously exhibited at The Art Guild will not be considered.

SIZE and FRAMING Frame size must not exceed **30"** on the longest side and wired securely for hanging with screw eyes or D-rings to the frame, NOT the backboard. No sawtooth hangers, tape, string, or gallery wraps. **Frame must be black**. Work must be labeled with the title, artist's name, street address, phone number, and email. Framing of your work must comply with the above OR IT WILL NOT BE ACCEPTED.

ENTRY FEE Registration is required and fees are non-refundable.

FINALISTS The Selection Committee will review all entries and notify each artist as to the acceptance of the submitted work. The Art Guild has the right, in its sole discretion, to choose which eligible entries will be accepted to be exhibited. All decisions are final. **Artists whose work** has been selected will be notified after February 17, either by email **OR** on our website.

AWARDS 1st Place \$300 • 2nd Place \$200 • 3rd Place \$100 and Honorable Mentions. Student awards will be judged separately and additional prizes will also be given, if appropriate.

SALES Artwork may be sold directly by the artist with a suggested donation of 20% of the selling price from the artist to The Art Guild.

LIABILITY and INSURANCE The Liability Waiver on the entry form must be signed by the artist submitting images for consideration. It is the responsibility of the participating artist to insure or self-insure any work submitted for inclusion in this exhibit.
